- 1. The Government of India has received a credit (Credit No. 42320 IN) from the International Development Association (IDA) towards the cost of Uttarakhand Rural Water Supply and Sanitation Project (URWSSP), and intends to apply part of the proceeds of this credit to payments under the contract for hiring Consultants/Consultancy Firms for preparation of Implementation Phase Completion Report (IPCR) of Single/Multi Village water supply schemes of Uttarakhand.
- 2. The project intends to engage engineering consultants/Firms for preparing IPCRs and final settlement of accounts of completed schemes of Uttarakhand Peyjal Nigam & Uttarakhand Jal Sansthan. The consultant/consultancy firms shall work as an extended arm of the SWSM/PMU for Joint Inspection Report (JIR) and preparation of IPCR with the help of District Implementing Agency (DIA), Users Water Supply and Sanitation Sub Committee (UWSSC) and Support Organization (SO). Consultants/Firms will be paid on the basis of number of IPCRs prepared on fixed rate of ₹ 13000.00 per IPCR in case of SVS and in case of MVS ₹13000.00 per UWSSC including supply main/Rising Work upto bulk storage (Including all expenses and taxes).

3. OBJECTIVE OF THE ASSIGNMENT

The main objective of this assignment is to prepare IPCR and formally finalize the settlement of accounts on the basis of Audit report and complete necessary formalities with the community regarding quality and cost of schemes.

QUALIFICATION OF CONSULTANTS

Experience of working in Hill Areas will be treated as additional qualification. The consultancy firm will ensure that the same personnel will work for the whole assignment period whose CV is attached with the application form, if in case any replacement is required then the replaced person should possess equivalent or higher qualifications and experience.
