The Government of Uttarakhand, Department of Drinking Water & Sanitation has applied for IDA Credit from the World Bank for financing of Uttarakhand Water Supply and Sanitation Program (UWSP) for Peri Urban Areas.

The consulting services “**Public Private Partnerships Models**” includes to evaluate strategic options and pre-feasibility assessment for developing multi-village water supply schemes through public-private participation (PPP) in peri urban areas. The output of this study shall be used to inform DDWS as well as the World Bank Group, on the nature and scope of private sector participation that can be expected or implemented in this project. This would in turn inform the design of the World Bank support for the project.

The State Water & Sanitation Mission, Uttarakhand now invites consultancy firms to indicate their interest in providing the services. Interested firms must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc) Consultants (firms) may associate to enhance their qualifications. The short-listing criteria are:

(i) Age of the firm; (ii) Number of Post Graduate in Business Administration, Finance and CA (iii) Completed similar assignment since last three financial year (i.e from 1st April, 2013); (iv) Experience of working in similar geographical areas (i.e Himalayan belt of India) and (v) Average annual turnover in last three financial year. Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the Qualification & Cost based Selection-Lump-sum method set out in the Uttarakhand Procurement Rules 2008 and its amendments.
